



If he deposits the said amount within two months the entire proceeding against him will be dropped. The Certificate proceeding against him shall remain stayed till 26/12/16. It will be open to the dealer to deposit Rs 1,75,000/- by 24/11/16 and the balance by 24/12/16.






Nagina Rai S/o PDS dealer Gulabia Devi is present. District Engineer, Vaishali is also present.

The erstwhile PDS dealer Ram Briksha Rai was left with 437.07 quintals of rice. He died in 2009. His assets evolved upon his wife and son Nagina Rai. On compassionate ground license of fair price shop was granted to the widow Gulabia Devi. The shop is now being run by Nagina Rai S/o Late Ram Briksha Rai. The value of left over grains must be paid by Gulabia Devi and Nagina Rai. The value of 437.07 quintals of rice comes to Rs 5,98,000/- which may be read as Rs 6,00,000/-. Gulabia Devi and Nagina Rai must deposit Rs 3,00,000/- within two months failing which the law will take its own course. They must deposit Rs 1,50,000/- by 24/11/16 and the balance sum of Rs 1,50,000/- may be deposited by 26/12/16. The Certificate proceeding will remain stayed till 25/11/16.
