When the scheme was closed in March, 2006 the dealer was left with 182.85 quintals of rice, the price of which would Rs 2,50,367/-. The dealer has already deposited Rs 1,66,451. He has thus deposited more than 50%. Question is now whether he should be called upon to deposit the balance amount. No ostensible reason has been shown by the dealer that why should not be called upon to pay the balance. There was an obligation upon him to keep the grains in good condition in terms of license order. He says that he told the authorities about the residual grains. It is difficult to accept. He did not submit anything in writing before the authorities. He is now liable to pay the price. There are latches on the part of BDO also. Seeing the latches on both sides I am inclined to give a grant of 15% on the balance 50% to the dealer. He will now have to deposit Rs 46,300/- failing which he will not get the benefit of handling and transportation charges of Rs 50/- per quintal. If he deposits that amount the authorities may grant him the handling and transportation charges.

Mr K.K. Mishra, learned counsel for the State objects for the rebate being given to the dealer on the ground that it was the duty of the dealer to keep the grains in good condition. It is true that there is obligation upon the dealer to keep the grains in good condition but there is also obligation on the part of authorities to take urgent steps for disposal of the grains. Till 2011 i.e. five years after closure of the scheme no action taken by the authorities for disposal of the grains. That is why I have granted 15% rebate to the dealer. If he does not deposit the amount within two months, the rebate will not be available to him and no handling and transportation charges will be paid to him. It is axiomatic that if he deposits the said sum of Rs 46,000/- to receive the rebate of 15% and the handling and transportation charges, the shortfall of 15% may be the matter for consideration why it is not be realized from the Officer/Officers for not taking appropriate steps. Let notice be issued to the then Mukhiya/Panchayat Secretary in the year 2005-06 and also the present Panchayat Secretary of Karma Panchayat to be present before us on 21/07/17.


