PDS dealer Raj Kumar Singh is represented by his learned counsel Mr Birendra Kumar Sinha. BDO, Mahnar is present.

Learned counsel has submitted the claims with regard to transportation, handling etc on behalf of his client after already depositing the 50% of the demand and prays for hearing on the next date.

However, BDO, Mahnar submits that the total demand being shown in the FIR against the dealer was for Rs 497 quintals and the petitioner himself had made prayer before the Hon'ble Court admitting the sam quantum of the grains, so his submission before this Commission that he owes only 434 quintals of grains should not be considered as final. At this juncture, Counsel for the petitioner submits that his client would meet the BDO with his papers like stock register and permits etc and satisfy the BDO before the next date. BDO should also take care to provide him a patient hearing on the issue of divergence so that a final report may be placed before this Commission on the issue of 50% deposit of the demanded sum. Counsel for the petitioner is ready to cooperate with the condition that before final hearing 50% of the amount would be deposited.

Mr Rajesh Bharti, the then BDO has appeared in person along with his learned counsel Mr Abhay Shankar Singh. Learned counsel submits that he has not received the papers being demanded from the block office and the BDO, Mahnar has sent him an interim letter that the documents being sought for are being looked into. In view of the prayer of the learned counsel for an adjournment is allowed. Moreover, counsel for Mr Bharti has prayed to exempt his client from personal appearance from the next date. Learned counsel has assured that he would be cooperating with the process of the Commission on his behalf. So Mr Rajesh Bharti is being exempted from personal appearance. Learned counsel on his behalf must file a detailed show cause by the next date.
