

There was a demand of Rs 2,61,689/- against the dealer. He has deposited only Rs 1,10,000/- prior to 23/12/16. He had stated on affidavit that he was willing to deposit the entire balance sum of Rs 1,51,689/-. He was permitted to deposit Rs 75,000/- by 23/01/17 and the balance sum by 23/02/176. There is a report of the BDO showing that the dealer has deposited only Rs 20,000/- more. Thus the dealer has deposited 50% of the entire sum since he was willing to deposit the entire sum Let notice be issued to the dealer and the BDO to be present on the next date.
