ORDER

PDS dealer Bijli Paswan is absent. BDO, Gauraboram block is present.

The dealer has stated in his written representation that when the scheme was closed, 50 quintals of rice remained with him as residue. The price thereof @ Rs 1370/- per quintal comes to Rs 68,500/-. He deposited Rs 40,000/- in two instalments. Later, on Rs 28,500/- has also been deposited. The dealer has thus deposited the entire sum. In that view of the matter, there is no dues against the dealer. BDO will examine the correctness of the statement of the dealer.

The dealer is entitled to transportation and handling charges @ Rs 13/- per quintal on the total quantity of rice lifted by him. He will put his claim before the BDO, Gauraboram block/DDC, Darbhanga. They will see that the dealer is paid the transportation and handling charges.

The application of Bijli Paswan is allowed.
