PDS dealer Ashok Kumar and BDO, Maner are present.

The dealer had lifted 723 quintals of rice. He had distributed 602.85 quintal leaving a balance of Rs 120.15 quintals. The value thereof @ Rs 1370/- per quintal was Rs 1,64,605/-. He has deposited Rs 82,200/- i.e. 50% of the total demand. He has not filed any representation why the balance sum should not be realised from him. Orally he has stated that the rice had deteriorated but he had not informed any authority either the Panchayat Secretary or BDO about the rice having got rotten. I cannot conceive a dealer in rice throwing away 240 bags of rice. There was door open for black market. Therefore he must deposit the balance sum of Rs 82,405/- within one month. The dealer will be entitled to transportation and handling charges @ Rs 50/- per quintal.

If he does not deposit the balance sum within one month, handling and transportation charges will not be paid to him and the BDO will be free to demand from the dues under Bihar Recovery Act.

Nagendra Kumar, husband of PDS dealer Smt Sangita Devi and BDO, Maner are present.

When the scheme was closed after distribution of 139.88 quintals of rice she was left with 390.94 quintal the price of which would be Rs 5,35,587/-. Up till now she has not deposited 50% of the demand which would entitle her to move this Commission in terms of order of Mr M.K. Jha J. She has deposited only Rs 70,000/-. Mr Dineshwar Mishra, learned counsel for the dealer prays that she may be granted some time to deposit 50% of the demand for the present. 50% of the demand after deduction of the sum of Rs 70,000/- deposited by her would be Rs 1,97,793/-. This sum she must deposit within one month. Thereafter, plea of the dealer will be considered.
