He has produced a letter dated 24/07/2017 written by him to the BDO to supply the Scheme Register. In that situation, he is unable to substantiate his case. The then BDO is absent although he was summoned. The DDC, Vaishali will examine why cash component was not supplied. DDC will take action against the then BDO and report to this Commission why cash component was not made available which resulted in loss to the State Government.
